This first payment will be refunded if the applicant is not admitted to the exhibition (see "General Regulations", Articles A8.1, A8.2), but will be forfeited if unilaterally the applicant withdraws totally from the undertaking (for partial withdrawals, see "General Regulations", Articles A12.4, A12.5, A12.6), or if the Rental Contract is terminated prematurely (see "General Regulations", Articles A8.4, A8.6).
